This Contract must be extended for a term of six (6) months, thru February 28, 2017, with no additional funds required.

1. The reason for this short-term extension is to facilitate the rebid of the new solicitation.
2. This action is being carried-out with the concurrence of the Contractors and the using agency.
3. The current inflation rate (CPI) is 12.13% and the Contractors have agreed to maintain the current pricing structure, which has been in effect since 2010.
4. There is no State of Arizona or other Intergovernmental Agreement Contract in effect for the items or services covered under this Contract.
5. Previous Expended Contract Amount (if applicable) \$374,959.66 as of August 18, 2016.
6. Second Call Contractor, Valley Wide Electric Co., has declined the offer to extend, and will be taken off the contract effective September 1, 2016 (see e-mail attached).
7. Diamond Ridge Development will become Second Call contractor on the contract effective September 1, 2016.
