

AMENDMENT NO. 2
AGREEMENT FOR TEMPORARY WORKERS FOR RECYCLING FACILITY,
LANDFILL AND PUBLIC WORKS
(City of Glendale Solicitation No. RFP 15-17, Contract No. C-10229)

This Amendment No. 2 ("Amendment") to the Temporary Workers for Recycling Facility, Landfill and Public Works ("Agreement") is made this 21 day of September, 2016, ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and JG Staffing, Inc., an Arizona corporation authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and JG Staffing, Inc. ("Contractor") previously entered into Agreement for temporary workers for Recycling Facility, Landfill and Public Works, Contract No. C-10229, dated August 28, 2015 ("Agreement"); and
- B. The Agreement had an initial one-year term beginning August 28, 2015 through August 27, 2016 and provided the option to extend for an additional four (4) years in one year increments; and
- C. City and Contractor previously entered into Agreement Amendment No. 1, extending the term of the Agreement from August 29, 2016 through August 28, 2017; and
- D. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of the Agreement is unchanged and shall expire on August 28, 2017.
- 3. **Scope of Work.** The Scope of Work shall be amended to include the change of name, TIN and address as per Exhibit A.

4. **Compensation.** The compensation of the Agreement is unchanged and not to exceed \$875,153 per fiscal year, or a maximum of \$4,375,765 if the City exercises all renewal options.
5. **Insurance Certificate.** Current certificate will expire on May 4, 2017 and a new certificate applying to the extended term must be provided prior to this date to Materials Management and the Contract Administrator.
6. **Non-discrimination.** Contractor must not discriminate against any employee or applicant for employment on the basis of race, color, religion, sex, national origin, age, marital status, sexual orientation, gender identity or expression, genetic characteristics, familial status, U.S. military veteran status or any disability. Contractor will require any Sub-contractor to be bound to the same requirements as stated within this section. Contractor, and on behalf of any subcontractors, warrants compliance with this section.
7. **No Boycott of Israel.** The Parties agree that they are not currently engaged in, and agree that for the duration of the Agreement they will not engage in, a boycott of Israel, as that term is defined in A.R.S. §35-393.
8. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.




