## AMENDMENT NO. 4

### COURT SECURITY GUARD SERVICES AGREEMENT (RFP NO. 09-11, Contract No.C-7026)

This Amendment No. 4 to Court Security Guard Services Agreement ("Amendment") is made effective on the 1st day of October, 2014 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and CBI Security Services, Inc., a Utah corporation authorized to do business in Arizona ("Contractor").

#### RECITALS

- A. City and Contractor previously entered into an Agreement, Contract No. C-7026, dated September 10, 2009 ("Agreement"); and
- B. The Agreement had an initial two-year term beginning October 1, 2009 through September 30, 2011, and provided the option to extend the term for an additional four (4) years in one-year increments; and
- C. City and Contractor previously entered into Amendment No. 1, extending the term from October 1, 2011 through September 30, 2012; and
- D. City and Contractor previously entered into Amendment No. 2, extending the term from October 1, 2012 through September 30, 2013; and
- E. City and Contractor previously amended the Agreement, extending the term from October 1, 2013 through September 30, 2014.
- B. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

#### AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of the Agreement is extended for a one year period from October 1, 2014 through September 30, 2015, unless otherwise terminated or canceled as provided by the Agreement.


3. **Compensation.** Contractor's compensation as provided in Exhibit B of the agreement is hereby amended as set forth in Exhibit B-Amendment No. 4, attached hereto.
4. **Insurance Certificate.** The existing insurance certificate is expiring and a new certificate applying to the extended term is required and must be received by the Contract Specialist within 10 business days of execution of this Agreement.
5. **Ratification of Agreement.** City and Contractor hereby agree that, except as expressly provided herein, the provisions of the Agreement are, and shall remain in full force and effect. In the event any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.
6. **Effective Date.** The effective date of this amendment is the date it is signed by the city.


