## AMENDMENT NO. 5

### SEWER LINE CLEANING SERVICES AGREEMENT (RFQ 10-12 Contract No. C-7193)

This Amendment No. 5 to Sewer Line Cleaning Services Agreement ("Amendment") is made effective on the 14 day of JANUARY, 2015 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and Reddi Root'r, Inc., a Kansas corporation authorized to do business in Arizona ("Contractor").

#### RECITALS

- A. City and Contractor previously entered into Sewer Line Cleaning Services Agreement, Contract No. C-7193, dated February 12, 2010 ("Agreement"); and
- B. The Agreement had an initial one-year term beginning February 12, 2010 through February 11, 2011 and provided the option to extend the term for an additional five (5) years in one-year increments; and
- C. City and Contractor previously entered into Amendment No. 1, extending the term of the Agreement from February 12, 2011 through February 11, 2012; and
- D. City and Contractor previously amended the Agreement, extending the term from February 12, 2012 through February 11, 2013; and
- E. City and Contractor previously amended the Agreement, extending the term from February 12, 2013 through February 11, 2014; and
- H. City and Contractor previously amended the Agreement, extending the term from February 12, 2014 through February 11, 2015.
- I. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

#### AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
2. **Term.** The term of the Agreement is extended for a final one-year period from February 12, 2015 through February 11, 2016, unless terminated or canceled as provided within the Agreement. All other provisions of the Agreement shall remain in their entirety.


3. **Scope of Work.** The Scope of Work is unchanged.
4. **Compensation.** The compensation of the Agreement is unchanged.
5. **Insurance Certificate.** The existing insurance certificate is expiring and a new certificate applying to the extended term is required and must be received by the Contract Specialist within 10 business days of execution of this Agreement.
6. **Ratification of Agreement.** City and Contractor hereby agree that, except as expressly provided herein, the provisions of the Agreement are, and shall remain in full force and effect. In the event any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.




