**AMENDMENT NO. 4**

**AGREEMENT FOR CODIFICATION OF CITY CODE (Contract No. C-7250)  
City of Glendale Solicitation No. RFQ 10-32**

This Amendment to the Agreement for Codification of City Code is made this 23rd day of January, 2014 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and Municipal Code Corporation, a Florida corporation authorized to do business in Arizona ("Contractor").

**RECITALS**

- A. City and Contractor previously entered into an Agreement for Codification of City Code, Contract No. C-7250, dated May 1, 2010 ("Agreement"); and
- B. City and Contractor previously amended the Agreement February 11, 2011 (Contract Amendment #1);
- C. City and Contractor previously amended the Agreement March 16, 2012 (Contract Amendment #2);
- D. City and Contractor previously amended the Agreement March 27, 2013 (Contract Amendment #3);
- E. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

**AGREEMENT**

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of the Agreement is extended for a one (1) year period from May 1, 2014 through April 30, 2015, unless otherwise terminated or canceled as provided by the Agreement.
- 3. **Compensation.** Contractor's compensation is amended as of the Effective Date of this Amendment and Exhibit B of the original Agreement is amended as set forth in Exhibit B-Amendment No. 1, attached hereto.

### AMENDED COMPENSATION
