AMENDMENT NO. 5

PSYCHOLOGICAL SERVICES FOR THE POLICE DEPARTMENT AGREEMENT
(City of Glendale Solicitation RFP 10-33, Contract No. C-7277)

This Amendment No. 5 ("Amendment") to the Psychological Services for the Police Department Agreement ("Agreement") is made this 22 day of July, 2015 to be effective as of the 11th day of May, 2015 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and Jeni McCutcheon, Psy.D., P.L.L.C., an Arizona professional limited liability company ("Contractor").

RECITALS

- A. City and Contractor previously entered into a Psychological Services for the Police Department, Contract No. C-7277, dated May 13, 2010 ("Agreement"); and
- B. The Agreement had an initial one-year term beginning May 11, 2010 through May 10, 2011 and provided the option to extend for an additional five (5) years in one-year increments; and
- C. City and Contractor previously entered into Agreement Amendment No. 1, extending the term of the Agreement from May 11, 2011 through May 10, 2012; and
- D. City and Contractor previously entered into Amendment No. 2, extending the term of the Agreement from May 11, 2012 through May 10, 2013; and
- E. City and Contractor previously entered into Amendment No. 3, extending the term of the Agreement from May 11, 2013 through May 10, 2014; and
- F. City and Contractor previously entered into Amendment No. 4, extending the term of the Agreement from May 11, 2014 through May 10, 2015; and
- G. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.


AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
2. **Term.** The term of the Agreement is extended on a month-to-month basis beginning May 11, 2015 through September 10, 2015, until terminated or canceled as provided in the Agreement. All other provisions of the Agreement except as set forth in this Amendment shall remain in their entirety.
3. **Scope of Work.** The Scope of Work is unchanged.
4. **Compensation.** The compensation of the Agreement is unchanged.
5. **Insurance Certificate.** The existing insurance certificate will be expiring and a new certificate applying to the extended term is required and must be received by the Contract Specialist prior to the execution of this Amendment.
6. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.




