GLENDALE CIVIC CENTER CATERING LICENSE AGREEMENT  
(Solicitation No. RFP 11-04)

This Amendment No. 1 ("Amendment") for Glendale Civic Center Catering License Agreement is made to be effective 2 day of April 2015 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and Glendale AZCAT LLC, an Arizona limited liability company ("Caterer") collectively referred to as "Parties".

RECITALS

- A. City and Contractor previously entered into the Glendale Civic Center Catering License Agreement, Contract No. C- 7369, dated August 5, 2010 ("Agreement"); and
- B. The Agreement had an initial five (5) year term beginning August 5, 2010 through August 4, 2015 providing the option to extend the term for an additional three (3) years in one-year increments; and
- C. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.


AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of the Agreement is extended for a one-year period from August 5, 2015 through August 4, 2016, unless terminated, or canceled as provided within the Agreement. All other provisions of the Agreement shall remain in their entirety.
- 3. **Scope of Work.** The Scope of Work is unchanged.
- 4. **Compensation.** The compensation of the Agreement is unchanged.
- 5. **Insurance Certificate.** The existing insurance certificate is expiring and a new certificate applying to the extended term is required and must be received by the Materials Management prior to the execution of this Amendment.

6. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.




