AMENDMENT NO. 2

AGREEMENT FOR STAFFING FOR EVENT PARKING CONCESSION
(Contract No. 7460, City of Glendale Solicitation No. RFQ 11-29)

This Amendment No. 2 to the Agreement for Staffing for Event Parking Concession is made this 1st day of November, 2012, by and between the City of Glendale, an Arizona municipal corporation ("City") and Pro EM Party and Event Rentals Holdings, Inc., a Delaware corporation, authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and Contractor entered into an Agreement for Staffing for Event Parking Concession, Contract No. C-7460, dated November 20, 2010 ("Agreement");
- B. City and Contractor amended the Agreement with Contract Amendment No. One (1) effective September 14, 2011 extending the term from November 10, 2011 through November 9, 2012; and
- C. City and Contractor wish to further modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

- 1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.
- 2. **Term.** The term of the Agreement is extended for a one (1) year period from November 20, 2012 through November 9, 2013, unless otherwise terminated or canceled as provided by the Agreement. There are two contract extensions remaining that the parties may exercise. In no event shall the term of this Agreement extend beyond November 9, 2015.
- 3. **Exhibit A (Project).** The Scope of Work, Section 42.2 (Events), attached to the Agreement as Exhibit A is hereby amended to reflect the removal of the Glendale Jazz & Blues Festival from the City of Glendale FY2012-13 Festival Season.


4. **Insurance Certificate.** The existing insurance certificate is expiring and a new certificate applying to the extended term is required and must be received by the Contract Specialist prior to execution of this Amendment.
5. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.
