AMENDMENT NO. 4

AGREEMENT FOR STAFFING FOR EVENT PARKING CONCESSION (RFP 11-29 Contract No. C-7460)

This Amendment No. 4 for Agreement for Staffing for Event Parking Concession ("Amendment") is made to be effective the 10th day of November, 2014 ("Effective Date"), by and between the City of Glendale, an Arizona municipal corporation ("City") and PRO EM Party Event & Rentals LLC., a Delaware limited liability company authorized to do business in Arizona ("Contractor").

RECITALS

- A. City and Contractor previously entered into Agreement for Staffing for Event Parking Concession, Contract No. C-7460, dated November 10, 2010 ("Agreement"); and
- B. The Agreement had an initial one-year term beginning November 10, 2010 through November 9, 2011, and provided the option to extend the term for an additional four (4) years in one-year increments; and
- C. City and Contractor previously entered into Contract Amendment No. 1, extending the term of the Agreement from November 10, 2011 through November 9, 2012; and
- D. City and Contractor previously entered into Amendment No. 2, extending the term of the Agreement from November 10, 2012 through November 9, 2013; and
- E. City and Contractor previously entered into Amendment No. 3, extending the term of the Agreement from November 10, 2013 through November 9, 2014.
- F. City and Contractor wish to modify and amend the Agreement subject to and strictly in accordance with the terms of this Amendment.

AGREEMENT

In consideration of the mutual promises set forth herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the City and Contractor hereby agree as follows:

1. **Recitals.** The recitals set forth above are not merely recitals, but form an integral part of this Amendment.


2. **Term.** The term of the Agreement is extended for a one-year period from November 10, 2014 through November 09, 2015, unless terminated or canceled as provided in the Agreement. In no event shall the term of this Agreement extend beyond November 9, 2015. All other provisions of the Agreement shall remain in their entirety.
3. **Scope of Work.** The Scope of Work is unchanged.
4. **Compensation.** The compensation of the Agreement is unchanged and not to exceed \$15,000.00 for the new term.
5. **Insurance Certificate.** The existing insurance certificate is expiring and a new certificate applying to the extended term is required and must be received by the Contract Specialist prior to the execution of this Amendment.
6. **Ratification of Agreement.** City and Contractor hereby agree that except as expressly provided herein, the provisions of the Agreement shall be, and remain in full force and effect and that if any provision of this Amendment conflicts with the Agreement, then the provisions of this Amendment shall prevail.


